\_\_\_\_\_ **Late pick-up:** \$15.00 for the first 15 minutes and \$1.00 per each additional minute thereafter.

\_\_\_\_\_ **NSF:** \$29.00 for any check returned by your bank for insufficient funds.

\_\_\_\_\_ **Late Payment:** \$15.00 after the 8<sup>th</sup> of each month and 1.5% surcharge on outstanding balance after the 15<sup>th</sup> of each month.

\_\_\_\_\_ **Withdrawal:** I understand that I may voluntarily withdraw my child from TTPWS by giving four (4) weeks written notice to the Director prior to withdrawing the child. I understand that I am responsible for tuition charges if I remove my child without giving four (4) weeks notice. This applies to VPK and Voucher Families as well. You will be responsible for the FULL tuition amount if required notice is not given.

\_\_\_\_\_ **Lunch:** I understand that I may be charged \$5.00 for an emergency lunch fee if I forget to send a lunch for my child (when applicable).

\_\_\_\_\_ **August:** I agree to pay for the four days of **August Summer Camp tuition**, and understand that if I leave TTPWS owing this money, I will be subject to collections and my account will not be considered to be in good standing.
